

2023 Legislative Agenda

During the 88th session of the Texas Legislature, Texas ASCD supports the following positions and priorities:

ADEQUATE AND APPROPRIATE FUNDING

- Increase the Basic Allotment to equal or surpass the national average.
- Support enrollment as the standard for school funding instead of the average daily attendance.
- Provide appropriate funding that fully funds all components of House Bill 3.
- Appropriately fund staff, materials, and resources necessary for mandated accelerated instruction to meet the Student Success Initiative and graduation requirements.
- Increase funding to support English Language Learners, Special Education students and for high quality early childhood programs, including funding of full day Pre-Kindergarten for all students.
- Increase funding for the Technology and Instructional Materials Allotment and for professional learning.
- Oppose any effort to create vouchers, a tax credit scholarship program, or other programs that would fund private school tuition or homeschooling at the expense of public schools.

IMPROVE EDUCATOR EFFECTIVENESS

- Ensure resources and support for educator preparation programs and on-going professional learning programs.
- Provide resources and time for induction and on-going, multi-year mentoring programs for teachers new to the profession.
- Provide resources for on-going, job-embedded professional learning opportunities and leadership training opportunities for teachers and administrators to meet the changing needs of students and the profession.

ASSESSMENT AND ACCOUNTABILITY

Enact a flexible system of assessment and accountability to provide a comprehensive view of the strengths and needs of schools and students by broadening the state accountability system to include meaningful, diversified data points.

A new accountability system should:

- Focus on high-priority learning standards.
- Include elements each community considers important along with elements of the Texas Whole Child Initiative.
- Reduce the number of state required tests to only those required to meet Federal requirements and reduce the length of the tests to a developmentally appropriate length of time.
- Provide an alternative assessment method that allows students to graduate when they are unable to pass an End of Course (EOC) test after multiple attempts.

AUTONOMY AND FLEXIBILITY

- Strengthen autonomy and flexibility for school districts and locally elected trustees to respond to the differing needs of their students and communities including implementation of safety and security actions.
- Ensure that new statutory requirements become effective only when such requirements are fully funded by the Legislature. Reduce existing mandates and ease administrative requirements.

FUTURE-READY EDUCATION FOR THE WHOLE CHILD

Promote the Texas Whole Child Initiative to ensure that:

- Each student is healthy, physically and emotionally safe, engaged in learning, supported by qualified, caring adults, and challenged academically.
- Each student is prepared through a well-rounded, student centered education so that all high school students in Texas are college, career, and military ready upon graduation.
- Each student is provided access to a student centered learning environment and the supports needed to maximize their potential.
